



1) Booking and Payment:

The photographer Brandy Dennis agrees to preform the professional photographic services for the wedding of Dwonseia Roshell Cheeks and Lynn Leggins on the 02 of September 2017 at The Crystal Ballroom at Veranda from 10:00 a.m. until 10:30 p.m.

2) Service Agreement:

Brandy Dennis Photography (BDP) guarantees it's services up to but not to exceed the photographic fees paid by the client to BDP. Services include the digital photographing of the above event by photographer Brandy Dennis at the above specific time and place for the above specific time for the event.

3) Exclusionary:

Brandy Dennis Photography shall be the exclusive photographer retained by the client for the purposes of Photographing the wedding. Family and friends shall be permitted to photograph the wedding as long as they do not interfere with the photographer's duties and do not photograph the poses arranged by the photographer.

4) Delivery:

Photos will be available for viewing 5-6 weeks after the event and on-line proofing for client, family and friends will be available through Pixieset for three months. Purchases made through Pixieset are only guaranteed through Pixieset and not through Brandy Dennis Photography and it's photographers. See Pixieset terms of service for more details. Once the photos come off-line, the client will be given one CD/ DVD archive of all the images (edited) photographed during the event along with a proof book of all images. Brandy Dennis will hand deliver the proof book along with the archival DVD.

5) Copyright:

All photography Copyright © by Brandy Dennis and Brandy Dennis Photography. The photographer (Brandy Dennis) and BDP reserves the right to use any photographs taken during the event for advertising and commercial use. The event may be posted on the BDP website with samples from the wedding and/ or used for promotional and marketing materials. Should the client not wish to have the event uploaded on the Internet for viewing or a sample placed on any of Brandy Dennis Photography's sites or used in marketing materials a request in writing must be given.

6) Cancellation:

Should an event be canceled due to the fault of the client, BDP reserves the right to keep any of the booking fee made by the client. The client may request a full "Opt Out" of the agreement no less than four months prior to the event. If it is less than four months to the time of the event, the photographer requires 50% of the total fees. If the event is canceled within 2 weeks of the event the photographer requires 75% of total fees.

7) Failure to Perform:

If the photographer can not perform this agreement due to fire, casualty, an act of God, or other cause beyond control of the parties, than the photographer shall return All Monies paid to the photographer and shall have no further liability with respect to the agreement. The limitation on Liability shall also apply in the event that the photographic materials are damaged in processing, lost through camera malfunction, or otherwise lost or damaged without fault on the photographer. The photographer makes every effort to keep any of the above from happening. No Specific Photograph is Guaranteed.

8) Client Usage Rights:

The client is granted limited usage for an unlimited amount of time for private and personal use only. Image files are non-transferable and can not be given, shared or sold to any third party. Web sharing of low resolution imagery is acceptable but must contain photo credit and/ or watermark. Images can not be shared larger than a 4x6 at 72dpi. Credit must read: "Photo By: Brandy Dennis". Please bring this contract with you to any Photography lab for proof of usage rights. Commercial use is strictly prohibited and punishable by a fine of no less than three times the commercial usage of the photo which is unlawfully used.
